The Medical Center Operating Board met, in Open Session, at 12:05 p.m., Friday, July 12, 2002, in the 23rd Floor Conference Room of Troutman Sanders Mays & Valentine,

1111 East Main Street in Richmond; E. Darracott Vaughan, Jr., M.D., Chair, presided. William G. Crutchfield, Jr., William H. Goodwin, Jr., Ms. Elizabeth A. Twohy, John I. Gallin, M.D., Eugene V. Fife, and John P. Ackerly, III, Rector, were present.

Also present were John T. Casteen, III, Leonard W. Sandridge, Jr., Alexander G. Gilliam, Jr., Paul J. Forch, R. Edward Howell, Arthur Garson, Jr., M.D., Ms. Sally Barber, and Ms. Jeanne Flippo Bailes.

The Chair opened the meeting by welcoming the new Members of the Medical Center Operating Board, Mr. Fife and Dr. Gallin. He then asked for suggestions on how the Board should function. Mr. Howell, Vice President and Chief Operating Officer of the Medical Center, spoke to the mission of the Medical Center. He also told the Board that *U.S. News and World Report*, in its annual survey of hospitals to be released several days hence, has ranked ten of the clinical services as being among the best in the country.

The Chair noted that he planned to call a minimum of four scheduled meetings of the Board during the year. It was agreed that the next meeting would take place in Charlottesville on September 19th, following the meeting of the UVIMCO Board.

On motion, the Board went into Executive Session at 12:30 p.m.

That the Medical Center Operating Board of the Board of Visitors of the University of Virginia go into Executive Session to discuss and evaluate certain proprietary, business-related information pertaining to the operations of the Medical Center: specifically confidential market data and market development, payor mix, strategic redeployment of personnel, capital development and fund-raising strategies, and current contract negotiations on managed care reimbursements and negotiations with affiliated clinics and the School of Medicine over

strategic business plans for enhancing health care and containing costs, the disclosure of which at this time would adversely affect the competitive position of the Medical Center. And further, to discuss and confer with legal counsel on our statutory obligations and Medical Center departmental compliance with regulatory and credentialing requirements, which also will necessarily involve consideration of the performance of individual employees and managers and business-related proprietary information, all as provided for in Section 2.2-3711 (A) (1), (7), (8) and (23) of the Code of Virginia.

And finally, that the Board go into Executive Session to consider proposed personnel actions regarding the appointment, reappointment, resignation, assignment, performance, and credentialing of specific medical staff and health care professionals, as provided for in Section 2.2-3711 (A) (1) of the Code of Virginia.

The Board resumed its meeting in Open Session at 2:55pm and after voting to certify that its Executive Session discussions had been conducted according to the exemptions provided in the Virginia Freedom of Information Act, considered two proposed resolutions.

AUTHORIZATION REGARDING ORGANIZATIONAL AND FINANCIAL MANAGEMENT FOR THE MEDICAL CENTER

WHEREAS, the Medical Center Operating Board further recognizes the importance of a strong, cooperative relationship between the Medical Center and the School of Medicine; and

WHEREAS, the Medical Center Operating Board believes that it is in the best interest of the Medical Center to provide Medical Center senior management with appropriate flexibility in order to meet successfully these significant challenges and to strengthen the Medical Center's relationship with the School of Medicine; and

WHEREAS, the Medical Center Operating Board has reviewed and endorsed the strategic direction of the Vice President and Chief Executive Officer of the Medical Center and the Dean and Vice President of the School of Medicine relative to the organization chart and bylaws and the financial relationship between the Medical Center and the School of Medicine and the commitment to planning at the System level;

RESOLVED that the Vice President and Chief Executive Officer of the Medical Center, in consultation with the Executive Vice President and Chief Operating Officer of the University and with the advice of the Dean and Vice President of the School of Medicine, is authorized to create an organizational structure for the delivery of care within the Medical Center and its facilities as the Vice President and Chief Executive Officer deems appropriate; and

RESOLVED FURTHER that the Vice President and Chief Executive Officer of the Medical Center, in consultation with the Executive Vice President and Chief Operating Officer of the University, is authorized to engage in joint planning efforts and financial sharing arrangements with the School of Medicine as the Vice President and Chief Executive Officer deems appropriate.
