BACKGROUND: As part of the University's efforts to become more internationalized, students have increasing opportunities to experience other cultures, languages and courses of study by participating in Study Abroad programs.

AGENDA ITEM: II. NCAA Report

ACTION REQUIRED: None

BACKGROUND: There has been increasing national concern about low graduation rates among student-athletes. In an effort to address graduation rates among scholarship student-athletes, the NCAA has conducted research and developed legislation intended to reform the academic standards and improve the academic performance of student-athletes.

DISCUSSION: The Director of Compliance for Athletics, Mr. David Storm, will review the NCAA's new requirements for initial eligibility and the new "progress toward a degree" requirements. These new requirements become effective in August 2003.

In addition, as customary with new and current members of the Board of Visitors, Mr. Storm will instruct the Board on current recruiting guidelines and restrictions enforced by the NCAA.

Mr. Storm, who recently joined the Athletics Department after serving as Director of Compliance at American University, is a 1991 graduate of the College of Arts and Sciences.
