RE: Minutes of the Meeting of the Medical Center Operating Board
on June 11, 2009

The Medical Center Operating Board of the Board of Visitors of the University of Virginia met, in Open Session, at 8:30 a.m., Thursday, June 11, 2009, in the Board Room at the Medical Center; E. Darracott Vaughan, Jr., M.D., Chair, presided.

W. Heywood Fralin, Sam D. Graham, Jr., M.D., William P. Kanto, Jr., M.D., Vincent J. Mastracco, Jr., The Hon. Lewis F. Payne, Edward J. Stemmler, M.D., and John O. Wynne were present. Randl L. Shure and Randy J. Koporc participated by telephone.

Steven T. DeKosky, M.D., John B. Hanks, M.D., R. Edward Howell, and Leonard W. Sandridge, all *ex officio* Members, also were present.

Other Board of Visitors members attending the meeting were Daniel R. Abramson, Ms. Helen E. Dragas, and Robert D. Hardie.

The Chair opened the meeting by mentioning that the Board of Visitors will vote on the appointment of Ms. Constance R. Kincheloe to the Medical Center Operating Board as of July 1, 2009, and she will attend the next meeting of the Board. He also stated that although Mr. Koporc has taken a new job out of town, he has chosen to remain on the Board to serve out his term. The Chair thanked Mr. Graham for his service on the Board. Mr. Graham's term will end June 30, 2009.

ACTION ITEM: Fiscal Year 2010 Medical Center Operating and Capital Budgets

Mr. Howell mentioned that the budgeting process for fiscal year 2010 began by updating the Long Range Financial Plan, drafting budget assumptions, and assuring that those assumptions are compatible with the Long Range Financial Plan. He stated that this budget was challenging to prepare because of lower inpatient volumes. Fiscal reality requires reduction of staffing by 129 FTEs, which will be accomplished by filling only positions essential for patient care or implementation of the Electronic Medical Record (EMR), and through re-assignment of employees. The uncertainty of healthcare reform is another challenge.

Mr. Howell called on Mr. Fitzgerald to review the budget. Mr. Fitzgerald stated the budget is consistent with the Long Range Financial Plan. It reflects investments in capital and employees, and a commitment to the School of Medicine.

Fiscal Year 2010 assumptions include admissions of 29,173, expanded bed capacity, an average length of stay of 5.9 days, a rate increase of seven to 9.9 percent, provision for employee and Resident raises, and a capital budget of \$75.9 million.

Mr. Fitzgerald explained that there were a number of challenges facing the Medical Center, including Medicare/Medicaid and indigent care funding, controlling supply costs, and the conversion to the EMR. The average length of stay, 5.9 days, is an

important number because a .1 drop in that number means the creation of eight beds. Operating income is projected to be \$48.9 million, and non-operating gains are budgeted at \$31.1 million, for a total net income of \$80 million. This could be off by as much as \$30 million. The operating margin is projected at 4.7 percent.

Mr. Fitzgerald expressed a concern about indigent care trending upward slightly and the percent of operating revenue from Medicare and Medicaid also trending up. Board members asked about contingency planning in the event federal funds diminish significantly. Ms. Cipriano responded that there are a number of pathways to improve efficiency. Dr. DeKosky remarked that we can't re-engineer out of the worst case scenario and there is no hospital that is able to do so. Dr. Garson stated that reform legislation will not be next year, but there are massive potential changes ahead. Dr. DeKosky added that legislative protection of academic medical centers may be necessary.

Mr. Howell asked for approval of the resolution endorsing the operating and capital budgets and recommending them to the Finance Committee and the Board of Visitors. Upon motion, the following budget resolution was approved:

RECOMMENDATION REGARDING FISCAL YEAR 2010 MEDICAL CENTER
OPERATING AND CAPITAL BUDGETS

WHEREAS, the Medical Center Operating Board has reviewed the Fiscal Year 2010 Medical Center operating and capital budgets;

RESOLVED, the Medical Center Operating Board endorses and recommends to the Finance Committee and to the Board of Visitors approval of the Fiscal Year 2010 Medical Center operating and capital budgets.

VICE PRESIDENT'S REMARKS

Mr. Howell reported that the Medical Center is very focused on decreasing Length of Stay and improving throughput so inpatient volumes can return to projected levels. He added that they are closely stewarding resources. Despite these challenges, a commitment has been made to the School of Nursing to hire all of their graduates who seek employment at UVA, and as of this date the Medical Center has hired 24 Bachelor of Science in Nursing recipients and 12 Clinical Nurse Leaders. Mr. Howell sees this as an investment with a long-term payoff.

Mr. Howell stated that capital projects continue on schedule and under budget and they are in the process of re-furbishing the fourth nursing unit.

The University Medical Center was named again as one of the nation's top 100 hospitals by Thomson Reuters. The Medical Center is one of only 15 major teaching hospitals nationwide to receive this distinction. This marks the eighth year the Medical Center has received this honor. A pamphlet was provided to all Board Members describing the recognition.

In addition to Top 100, 47 UVa physicians are included in this year's *Castle Connolly's America's Top Doctors*.

Mr. Howell mentioned the plan to become a smoke-free environment by October 1, 2009.

The Medical Center is working with Martha Jefferson Hospital to address pneumococcal immunization, a community-wide issue. The plan is to roll out the program in July or August with the goal of 100 percent immunization.

Mr. Howell asked David Neuman, University Architect, to discuss the area plan for the Health System. Mr. Neuman showed maps and drawings of the area and said we need to create a "sense of place" through a unifying design concept that also connects the area to the larger University Grounds. One map identified areas where facilities could be replaced or renewed in the future. Another showed green space improvements to major entrances to the area. This plan is intended to cover the next ten to twenty years.

BUCHANAN FUNDS

Mr. Howell stated that the Buchanan program was established in 2007 to encourage clinically differentiated programs. He introduced Karen Johnston, M.D., Chair of Neurology, to summarize this year's awards process and to introduce one of the awardees. Dr. Johnston stated there have been 21 awards so far. A program receives three years of funding and then must sustain itself. Revenues from these programs go to the general revenue and not back into the Buchanan fund. Dr. Johnston then reviewed the awards timeline for 2009. Dr. Johnston said out of 22 submissions, six were chosen for Stage Two, and three ultimately received awards.

Dr. Johnston introduced Anitha Jayakumar, M.D., who received an award to advance the fetal cardiology program. Dr. Jayakumar explained her group's work to improve diagnosis and treatment of congenital heart disease in babies. She stated that there are 800 cases of congenital heart disease in Virginia every year out of 100,000 births. The Medical Center's market share in 2007 was 25.2%,

but the optimal market share is 50%. The group believes the multidisciplinary approach at the University will attract more patients.

Dr. Vaughan commented that the Buchanan program is unique; it is seed money for programs that have great promise and this is unusual.

Mr. Howell gave a report on the Buchanan program. He said they have spent \$16 million with the goal to create clinical differentiation. Seven start-ups have been successful, and 2 have been unsuccessful. Twelve are in the three year start-up period. At the end of the three years start-up period a committee evaluates whether the program should continue.

REMARKS BY THE VICE PRESIDENT AND DEAN OF THE SCHOOL OF MEDICINE

Dr. Vaughan asked Dr. DeKosky to provide remarks. Dr. DeKosky mentioned the Carter/Harrison Building dedication, and how this building provides much needed research space. This is important for recruiting new faculty.

Dr. DeKosky said that over the last two years the National Institutes of Health reduced total funding dollars. This is a challenging time for researchers.

Dr. DeKosky also mentioned that the Fall 2009 Medical School class has been finalized. Totaling 144 students, they have the highest percentage of minorities and the highest academic credentials of any class.

OPERATIONS REPORT

Mr. Howell asked Ms. Cipriano to give the operations report. Ms. Cipriano explained the Biohazard Response Plan for contagious outbreaks. This plan was implemented in response to the H1N1 (swine flu) outbreak in April and May. The Plan's components include stockpile readiness, designating triage areas, having detailed plans ready if cases are confirmed in the region and at the University, and coordinating across Grounds and in the region.

REPORT BY THE PRESIDENT OF THE CLINICAL STAFF

The Chair asked Dr. Hanks, President of the Clinical Staff, to give his customary report.

Dr. Hanks' comments were centered on the Clinical Staff Retreat and the follow-up report. The fourth Clinical Staff Retreat was held on March 20, and 21, 2009, with a focus on the implementation of an

Electronic Medical Record (EMR). Four hundred members of the Clinical Staff, nursing colleagues, and administrators attended. The breakout sessions generated reports that he believes are well-reasoned and worth reading. Dr. Hanks and Dr. Gibson developed an executive summary of the reports.

Dr. Hanks stressed that EMR, like many other issues facing the Clinical Staff, must have as one of its final results the ability to make high quality medical care more efficient and attainable for clinicians. He thanked the Clinical Staff Office, including Priscilla Shuler and Stephanie Brown, for their tireless work in putting the Retreat together. He also recognized Dr. Gibson for his tireless work and thoughtful input to the report.

EXECUTIVE SESSION

After adopting the following motions enabling it to meet in Closed Session, the Medical Center Operating Board went into Executive Session at 10:00 a.m.:

That the Medical Center Operating Board go into Closed Session to discuss a proprietary report on a health care information management system and performance of a contract, Medical Center market strategies and potential joint ventures where public disclosure would adversely affect the Medical Center's bargaining position. To consider confidential information and data related to the adequacy and quality of professional services, patient safety in clinical care, and patient grievances all for the purpose of improving patient care, and in consultation with legal counsel, to discuss the Medical Center's compliance with relevant federal reimbursement regulations, licensure and accreditation standards, including Medicaid Disproportionate Share, and negotiations concerning performance of a contract and related litigation, which will also involve proprietary business information of the Medical Center. To evaluate the performance of specific Medical Center personnel where disclosure at this time would adversely affect the competitive position of the Medical Center. The foregoing motion is authorized by Sections 2.2-3711 (A) (1), (6), (7), (8), and (22) of the Code of Virginia. The Closed Session of the Medical Center Operating Board is further privileged under Section 8.01-581.17 of the Code of Virginia.
