Miscellaneous Fees 2000

In the 2000 questionnaire that the Cooper Center distributed, local governments were asked to specify any miscellaneous charges or fees that fell outside of the scope of the questions in the survey. The answers are included in **Table 27.1**.

Table 27.1 provides the responses of the 12 cities, 28 counties, and 22 towns that impose miscellaneous

fees. The table includes the type of fee imposed, the amount of the fee, and the schedule, if any, that applies to fee payment. Miscellaneous fees described include zoning and building permits, utility deposits, boating and fishing licenses, dog licenses, library cards, electrical and plumbing permits, and a variety of other fees that could not be fully categorized in terms of the other sections of the survey.
