It is the department's responsibility to correct all deficit sponsored program awards. If the department fails to take corrective action, OSP will move overages to Departmental F&A awards per Sponsored Programs procedure, <http://www.virginia.edu/finance/polproc/pol/viic2.html>.

You must respond to OSP with a plan of corrective action within **30 days** of the date of this letter for Awards listed under the **First Notice** category. **If you do not respond** OSP will transfer the deficit to your F&A award without further notification. Please note that departmental comments will not prevent a deficit from being cleared to your overhead account on the final notice. If OSP has agreed to a time extension for the final notice, it will be indicated in the comment section with the agreed upon date specified in that comment.

For clinical trial PTAEO's, OSP will allow budget overruns to occur throughout the life of the project. However, it is the responsibility of the department to monitor these balances to insure appropriate billing and payments have been processed. OSP will take action on clinical trials under the following circumstances:

1. the project has ended and the award/project has reached its final notice and no action has been taken by the department to clear the deficit
2. the deficit balance appears excessive or unreasonable and no documentation for the balance has been produced by the department.
