2011-2012 Student Health Insurance Continuation Plan

What is the Plan All About?

All Students and their eligible dependents who have been continuously insured under the school's regular student Policy for at least six consecutive months and who are no longer eligible under the Plan are eligible to continue their coverage at a higher premium rate. **This plan may not cover all your health care expenses.**

Important Details:

- Students and their dependents eligible for the 2011/2012 Student Health Insurance Plan are not eligible to purchase the Continuation Plan.
- You may continue coverage as long as the premium is received by Aetna Student Health within 31 days of your expiration date. Applications received after the 31 days will be returned and coverage will not be in effect.
- Coverage may be purchased for a 3, 6, 9, or 12 month Period of Coverage. However, in no event will Continuation Coverage extend beyond August 14, 2012 12:01 a.m.
- There is no renewable option or refunds of premium permitted. The period of coverage must be selected, and the total premium must be paid, at the time of enrollment.
- Enrollment instructions, a summary of the plan benefits, limitations, exclusions, and services will be available at www.uvastudentinsurance.com beginning July 15, 2011.

Who is eligible?

- Students and their eligible dependents who have lost their eligibility for the plan in force through graduation or otherwise leaving school.

Continuation of Coverage

A **covered student** and their **covered dependents** who has graduated or is otherwise ineligible for coverage under this policy, and has been continuously insured for six (6) months under the Aetna Student Health plan offered by the policyholder may be covered for up to 12 months provided that application and payment for the extended coverage is made to the policyholder within 31 days after the policyholder has given written notice of the continuation rights to the **covered person**, but in no event beyond the 60 day period following the date of the termination of the **covered person's** eligibility. Coverage under this provision will continue until the earliest of the following:

- The date the coverage has been continued 12 months
- The date this policy terminates.

Conversion

A **covered student** and their **covered dependents** who has graduated or is otherwise ineligible for coverage under this policy, and has been continuously insured for six (6) months under the Aetna Student Health plan offered by the Policyholder, have the right to convert to an individual policy. **Covered persons** are required to apply for the conversion policy within 31 days after the Policyholder has given written notice of the option to convert to an individual policy, but in no event beyond the 60 day period following the date of the termination of the **covered person's** eligibility.
